RED CROSS MONTH

WHEREAS, This March, we celebrate American Red Cross Month by recognizing the compassionate acts of people in Marina and by renewing our commitment to lend a helping hand to our neighbors in need. Since Clara Barton founded the American Red Cross more than 140 years ago, generation after generation has stepped up to deliver relief and care across our country and around the world, bringing out the best of humanity in times of crisis. Advancing this noble mission, the volunteers, blood and platelet donors, and supporters who now give back through the Central Coast Chapter remain unwavering in their commitment to prevent and alleviate human suffering in the face of today's emergencies.

WHEREAS, the contributions of local Red Cross volunteers (133 in the county) give hope to the most vulnerable in their darkest hours. Last year in Monterey County, volunteers helped 64 families affected by 30 home fires by addressing their urgent needs like food and lodging, as well as providing recovery support. In addition, they installed 655 smoke alarms, collected 1,939 blood donations, provided first aid and CPR training to 1,830 residents, and assisted 153 families of our armed forces.

We hereby recognize this month of March in honor of their remarkable service, and we ask everyone to join in their commitment to care for one another.

REQUEST:

It is requested that the City Council consider:

- 1. Adopting Resolution No. 2025- authorizing the City Manager to submit a Plan Amendment to the City's Permanent Local Housing Allocation (PLHA) grant.
- 2. Authorize Finance Director to make appropriate budgetary amendments.

BACKGROUND

On January 18, 2023, by adoption of the City Council resolution 2023-02, city staff were directed to file and apply for PLHA funds. On May 16, 2023, said funds were awarded for two key activities: preparation of pre-approved Accessory Dwelling Unit (ADU) plans and to establish a first-time home buyer program. The initial amount for each activity was estimated to be approximately \$313,000 for the pre-approved plans and the remainder allocated towards the first-time home buyer program.

After submitting for and receiving funds for the pre-approved ADU plans the total cost to the City of Marina was only \$78,000. Per the State HCD regulations if the City wants to move more than 10% of our PLHA funds within approved activities we need to reauthorize the grant with the City Council and State HCD. Additionally, since the original allocation of funds the PLHA regulations were changed to mandate that at least 40% of the funds be allocated towards home ownership activities. By allocating the funds toward the City's eventual First Time Home Buyer Program the City will be fulfilling this mandate.

ANALYSIS

Once the City Council approves the submission of the application to HCD, HCD is expected to approve the application and send the City a five-year Standard Agreement to be executed and signed within 90 days. All the first-year's allocation will be available for disbursement once the Standard Agreement is executed. Each year, HCD will publish the amount of funds the City will receive for the following year. To receive the funds, the City must submit a letter accepting the funds, its annual report detailing uses and expenditures of all awarded PLHA allocations and outcomes achieved, must have a certified Housing Element, and have submitted its latest Housing Element annual performance report.

FISCAL IMPACT

The City will be eligible for approximately \$945,290 in grant funding which can assist the City in meeting its regional housing needs allocation (RHNA).

SECOND AMENDMENT TO THE AGREEMENT FOR CONSTRUCTION MANAGEMENT AND CONSTRUCTION SUPPORT SERVICES FOR THE IMJIN PARKWAY WIDENING PROJECT

THIS SECOND AMENDMENT ("Second A	mendment") to the Agreement for

Project ("Project") is made this day of	, by and between the CITY OF
MARINA, a municipal corporation ("CITY") and HA	RRIS AND ASSOCIATES, INC., a
California corporation ("CONSULTANT"). CITY and	d CONSULTANT are sometimes referred
to herein collectively as the "Parties."	

Recitals

- A. On January 26, 2022, CITY and CONSULTANT entered into the Agreement for Construction Management and Construction Support Services for the Imjin Parkway Widening Project (the "Agreement") for CONSULTANT to perform preconstruction activities such as a constructability review of the project bid documents, providing community outreach, and to perform professional and environmental services necessary to during construction to fulfill all permitting and contract requirements in the amount of \$3,508,042.00.
- B. On April 27, 2023, CITY and CONSULTANT amended the Agreement for Construction Management and Construction Support Service ("Amendment No. 1") for additional services associated with the Project's Incidental Take Permit (ITP) in the amount of \$52,314.00.
- C. The Agreement provides it may only be amended or modified by written agreement of the Parties. Both Parties now desire to amend the Agreement to include additional services to be performed by CONSULTANT and additional compensation in the amount of \$416,496.84 to be furnished by the CITY.
- D. The CONSULTANT has prepared a document entitled "Imjin Parkway Widening Project: Additional Construction Management Scope of Work" with terms for the proposed Second Amendment of the Agreement (attached as "Exhibit 2" to this Second Amendment incorporated herein by reference).
- E. Only the numbered Articles of the Agreement which are being amended are set forth in this Second Amendment.

Terms & Conditions Amended

Now, therefore, the Parties agree to amend the Agreement as follows:

- 1. Exhibit "A1", "B1" and "C1" to the Second Amendment is incorporated into the Agreement.
- 2. Section 1 "Scope of Work" sub-section (a) is amended to read in its entirety:

- "(a) Contractor is hereby hired and retained by the City to work in a cooperative manner with the City to fully and adequately perform those services set forth in Exhibit "A", "A1" and "A2" attached hereto ("Scope of Work") and by this reference made a part hereof. With prior written notice to Contractor, City may elect to delete certain tasks of the Scope of Work at its sole discretion."
- 3. Section 1 "Scope of Work" sub-section (e) is amended to read in its entirety:
 - "(e) City shall cooperate with Contractor and will furnish all information data, records and reports existing and available to City to enable Contractor to carry out work outlined in Exhibit "A", "A1" and "A2". Contractor shall be entitled to reasonably rely on information, data, records and reports furnished by the City, however, the City makes no warranty as to the accuracy or completeness of any such information, data, records or reports available to it and provided to Contractor which were furnished to the City by a third party. Contractor shall have a duty to bring to the City's attention any deficiency or error it may discover in any information provided to the Contractor by the City or a third party."
- 4. Section 2 "Term of Agreement & Commencement of Work" is amended to read in its entirety:
 - "(a) Unless otherwise provided, the term of this Agreement shall begin on the date of its full execution and shall expire on December 31, 2026, unless extended by amendment or terminated earlier as provided herein. The date of full execution is defined as the date when all of the following events have occurred:
 - (i) This Agreement has been approved by the City's Council or by the board, officer or employee authorized to give such approval, and;
 - (ii) The office of the City Attorney has indicated in writing its approval of this Agreement as to form, and;
 - (iii) This Agreement has been signed on behalf of Contractor by the person or persons authorized to bind the Contractor hereto, and;
 - (iv) This Agreement has been signed on behalf of the City by the person designated to so sign by the City's Council or by the officer or employee authorized to enter into this Contract and is attested to by the Marina City Clerk.
 - (b) Contractor shall commence work on the Project upon full execution of this agreement. This Agreement may be extended upon written agreement of both parties. Contractor may be required to prepare a written schedule for the work to be performed, which schedule shall be approved by the City and made a part of Exhibit A, A1 and A2, and to perform the work in accordance with the approved schedule.
- 5. Section 3 "Compensation" sub-section (a) is amended to read in its entirety:
 - "(a) City liability for compensation to Contractor under this Agreement shall only be to the extent of the present appropriation to fund this Agreement. For services to be provided under this Agreement City shall compensate Contractor in an amount not to exceed Four Million Nine

Thousand Eight Hundred Fifty-Two Dollars and Eight-Four cents (\$4,009,852.84) in accordance with the provisions of this Section and the Cost Estimate attached hereto as Exhibit B, B1 and B2 and incorporated herein by this reference."

All other terms and conditions of the Agreement shall remain in full force and effect.

Edrie,

As you know, the bulk of our original scope of work was for the Construction Phase of this project with a limited effort in the Pre-Construction Phase. As the project team has moved through the process of obtaining the Incidental Take Permit (ITP) and now moved into the Construction Phase, I am reconciling our efforts for added work with our remaining budget. The table below summarizes Items 1-7 as additional scope of work for various efforts during the Pre-Construction Phase; Item 8 summarizes the basis for additional budget to continue our biological monitoring/reporting efforts through to project completion.

ITEM	DESCRIPTION									
1	Additional efforts for Community Outreach support during the Pre-Construction Phase. Efforts included additional coordination with the City and other agencies, and an extended period for the Pre-Construction Phase.									
2	Additional scope of work related to obtaining the project environmental permits. This item includes: Harris management/coordination efforts; deed research and surveying performed by Whitson Engineering; hazardous materials survey performed by Pacific Crest Engineers (part of the CDFW Lands Package); and inspection of layout and preparations to install the Habitat Mitigation Land (HML) fencing for the mitigation sites. Despite re-distributing budgets from other preconstruction tasks, it was not sufficient to cover these efforts.									
3	 Additional scope of work: Biological monitoring efforts for the limited clearing and installation of HML fencing. This effort was unknown until the environmental permitting process was completed (DD&A proposal Task 2) Pre-construction tree survey. The original tree survey (performed during the design phase approximately 5 years earlier) was outdated and not representative of existing conditions when construction was ready to commence. DD&A performed a tree survey for all trees within the project limits prior to any tree removal (DD&A proposal Task 1). 									

4	Additional scope of work for Paleontological Pre-Grade Survey. As part of the Paleontological Monitoring Plan development, this task was identified as a requirement due to the high sensitivity of several grading areas within the project boundaries. This effort was not included in the budget for other paleontological efforts in Amendment 1.
5	Additional scope of work for PG&E – Joby Avionics Construction Management Support. At the City's request, we provided CM support services for overseeing this work. Services included coordination with PG&E and their contractor, surveying (layout the limits of the Imjin Parkway improvements to avoid future conflicts with our work), and inspection of the PG&E contractor's efforts.
6	This item would allow charges for Miscellaneous Expenses not included in other cost items. Our original proposal did not include an item for Miscellaneous Expenses. This item does not change the overall budget but will be a re-distribution of the established "Document Control" budget and would be used primarily to cover the reproduction costs for redline/as-built plan sets.
7	This item would allow the option to charge the established IRS vehicle mileage rate for usage on the project_in lieu of monthly flat rate vehicle charges. This item does not change the overall budget for vehicle expenses; it is a re-allocation of this budget item.
8	The overall level of effort for monitoring and worker training required by the project permits was underestimated in our original proposal. Unforeseen tasks such as the full-time monitoring of Seaside Bird's Beak and a more robust monitoring of the condition of perimeter fencing for the project have added to the required effort. Please reference DD&A proposal Exhibit B.

The proposed increase in cost for the additional scope of work detailed above is \$416,496.84. I have attached Exhibit A detailing the costs of the individual items noted above. Additionally, I have attached Exhibit B which provides a detailed breakdown of DD&A's proposal for Item 8. All costs are based on work performed on an hourly basis.

Denise Duffy & Associates (DD&A) is currently under contract with Harris and Associates, Inc. (Harris) to provide environmental compliance services for the construction phase of the City of Marina's Imjin Parkway Improvement Project (project). Unforeseen construction activities that arose during project construction resulted in requests from Harris for additional environmental compliance from DD&A. This included monitoring of the Habitat Management Lands (HML) permanent fence and signage installation, full time monitoring of construction activities immediately adjacent to a population of seaside bird's beak (SBB), and pre-construction tree surveys. Additionally, construction phase biological monitoring for the project has exceeded the estimated budget and DD&A is requesting additional funds to provide biological monitoring for the duration of the construction phase. This document provides the Scope of Work (SOW) and Cost Estimate for these out-of-scope and extended environmental compliance services for the project. Out-of-scope environmental compliance services have been ongoing since August 2023. DD&A estimates approximately 17 months of construction to complete the project.

Task 1 Tree Survey

DD&A conducted surveys and tagged all trees within the project alignment proposed for removal that met the definition of a "tree" as defined in Marina City Code (Ch 17, §62.020). Surveys were conducted in August and September of 2023, and February, March, April, August, and September of 2024. In addition to the physical tree survey this task involved periodic coordination and strategy calls with City and project partners to coordinate information exchange and work with the internal team to address project needs, as well as revisions to the Tree and Vegetation Replacement Plan.

Task 2 HML Fence Installation Monitoring

The *Imjin Parkway Improvement Project Habitat Management Lands Long-Term Management Plan* (LTMP, DD&A 2024) directed that fencing for HML lands be installed during the months of August through January. Due to scheduling concerns permanent fencing was installed during the months of April and May. To allow for this modification to the LTMP the City of Marina (City) received approval from the California Department of Fish and Wildlife (CDFW) to install the fencing materials outside of the seasonal window with the

condition that a qualified biologist provides monitoring for installation located in known Monterey gilia populations. DD&A provided the biological monitoring as requested by the City.

Task 3. Extended Construction Phase Monitoring

Construction Phase for the project is expected to continue until June 2026. Due to the level of biological mitigation and monitoring required for this project, as well as the out-of-scope items discussed above, DD&A has exhausted the funds originally allocated for construction phase biological monitoring. This task includes the following:

- Performing Employee Environmental Educations for new construction personnel.
- Weekly construction site checks to confirm ESA fencing remains in good condition.
- Bi-weekly checks of the seedbank staging area.
- Construction meetings twice a week.
- Coordination with regulatory agencies.
- Biological monitoring as needed, on-call.
- Arborist services related to additional tree removal and installation of mitigation trees.
- To ensure no additional impacts are allowed to occur to the SBB population, DD&A will provide
 monitoring during construction activities within the immediate vicinity of the SBB population, as
 needed.

At the regular meeting of April 4, 2023, the City Council adopted Resolution No. 2023-32, approving a Public Improvement Agreement between the City and Lightfighter Village GP, LLC for the VTC "Lightfighter Village" Permanent Supportive Housing Project's public improvements. These improvements included utility connections, pavement restoration, concrete sidewalks, driveways and landscaping.

ANALYSIS:

The Improvements required by the improvement plans and approved by the City Engineer on May 19, 2023, were completed by the Developer in substantial conformance with the approved Improvement Plans for the project.

The Public Improvement Agreement states that a Guarantee and Warranty period will remain for one year after acceptance of the Improvements by the City Council.

Therefore, a request is being made by the Developer to release all of the Faithful Performance bond. A new bond of 10% of the original Performance bond (\$65,600) for public improvements will remain with the City Clerk as the Guarantee and Warranty Security for one (1) year after acceptance. Any repairs required during the Guarantee and Warranty period will be made by the Developer or the costs will be recovered from said bond. After the Warranty period, maintenance responsibilities for streetlights, sidewalks, pavement, and stormwater improvements will be covered by the City.

This Public Improvement Agreement for Streets, Installation of Sidewalks, Landscaping, Street Lights and Other Public Works Facilities (the "Agreement") is made and entered into this 2074 day of August, 2023, by and between the City of Marina, herein called the "City," a municipal corporation, and Lightfighter Village, L.P., a real property owner and developer, herein called the "Developer." City and Developer are sometimes hereinafter individually referred to as "Party" and hereinafter collectively referred to as the "Parties."

Recitals

- Developer has presented to City for approval a plan of development (the "Development") Α. located at 239-243 Hayes Circle, Marina, California (the "Property") within the City, pursuant to provisions of the City's Ordinances and Regulations relating to development approval.
- Marina Municipal Code Section 16.06.090 provides that improvements may include В. paving; gutter; curb; sidewalks; raised medians; street lights; street trees; landscaping; street signs; street barricades, walls and fences (the "Improvements") necessary along the frontage of the Property as described and shown on Off-Improvement Plan Sheet(s) (the "Improvement Plans"). Completion of all Improvements in accordance with the Improvement Plans shall be completed prior to final inspection.
- C. The Development has been approved, subject to the requirements and conditions on file in the Office of the Director of Public Works and incorporated into this Agreement by reference.
- The City has certain responsibilities for maintenance and operation of certain D. Improvements, utilities and public service facilities after acceptance by City, and the City agrees to discharge those responsibilities following its acceptance of the Improvements.

E. In consideration of the approval of the Development, Developer desires to enter into this Agreement, whereby Developer promises to install and complete, at Developer's own expense, the Improvements. Developer has secured its performance pursuant this Agreement by improvement security required by the City and approved by the City Attorney.

NOW THEREFORE, in consideration of the foregoing and in order to carry on the intent and purpose of said Codes, Ordinances, Resolutions, Rules and Regulations, it is agreed by and between the parties as follows:

SECTION 1

The recitals to this Agreement are hereby incorporated into the terms of this Agreement. All applicable Codes, Ordinances, Resolutions, Rules and Regulations and established policies of the City and the laws of the State of California and the United States of America concerning the subject matter of this Agreement are hereby referred to and incorporated herein to the same effect as if they were set out a length herein. Said Codes, Ordinances, Resolutions, Rules and Regulations include, but are not limited to, the following: The Municipal Code of the City of Marina, including the current Zoning Ordinance, and the currently adopted California Building Code. Performance by Developer of this Agreement shall not be construed to vest Developer's rights with respect to any change in any zoning or building law or ordinance.

Developer has been alerted to the requirements of California Labor Code section 1770 et seq. which require the payment of prevailing wage rates and the performance of other requirements if it is determined that this Agreement constitutes a public works contract. It shall be the sole responsibility of Developer to determine whether to pay prevailing wages for any or all work required by this Agreement. As a material part of this Agreement, Developer agrees to assume all risk of liability arising from any decision not to pay prevailing wages for the work required by this Agreement.

SECTION 2

The Developer agrees:

- a. To perform its obligations pursuant to this Agreement in accordance with each and every one of the applicable Codes, Ordinances, Resolutions, Rules and other Regulations and to comply with the foregoing and all applicable laws.
- b. [To grant to the City or other entities entitled thereto, without charge and free and clear of monetary liens and encumbrances, any and all public, private, utility, drainage, construction or access easements and rights of way (herein "easements") in and to the Improvements, to the extent necessary for the purpose of extending the Improvements; provided, however, City shall not be obligated to accept any such easements.]
- c. Prior to acceptance of the Improvements by the City, to indemnify, defend with counsel of City's choice and hold the City and any of its officials, boards and commissions and members thereof, agents and employees, free and harmless from all suits, fees, claims, demands, causes of action, costs, losses, damages, liabilities and expenses (including without limitation reasonable

attorney's fees) because of or arising or resulting directly or indirectly from (i) any damage done to any utility, public facility or other material or installation of the City ("City Real Estate") as a result of the Developer or any contractor or subcontractor of the Developer, or any employee of the foregoing, grading or working upon City Real Estate or (ii) any act or omission of Developer or Developer's contractors, or subcontractors, or any employee of the foregoing in connection with the design, construction or other work performed by them in connection with this Agreement, including without limitation all claims relating to injury or death of any person or damage to any property, except for such claims, demands, causes of action, liability or loss arising out of the sole negligence or intentional acts of the City or any of its officials, boards or commissions or members thereof, agents or employees. City shall not be responsible for the design or construction of the Property or the Improvements pursuant to the Improvement Plans, regardless of any negligent action or inaction taken by City in approving the Improvement Plans unless the particular improvement design was specifically required by City over written objection by Developer submitted to the City Engineer before construction and acceptance of the Improvements, which objection indicated that the particular improvement design was dangerous or defective and suggested an alternate safe and feasible design. Prior to acceptance, Developer shall remain obligated for routine maintenance of the Improvements. After acceptance, City shall be obligated for the routine maintenance of all Improvements but Developer shall remain obligated to eliminate any defect in design or dangerous condition caused by any design or construction defect. Provisions of this Section shall remain in full force and effect for ten years following acceptance by City of the Improvements. The Improvement security shall not be required to cover the provisions of this Section. Developer shall reimburse City for all reasonable costs and expenses (including but not limited to fees and charges of architects, engineers, attorneys, and other professionals, and court costs) incurred by City in enforcing the provisions of this Section.

To construct and improve, or have constructed and improved at its own cost, expense and d. liability, all public works facilities and other Improvements described in the Improvement Plans submitted to the City in furtherance of this Agreement on file with the City. To obtain, prior to commencing work all necessary permits and licenses and to give all incidental notices required for the lawful construction of the Improvements. If during the course of construction and installation of the Improvements, it is determined that the public interest requires alterations to the Improvements, Developer shall undertake such design and construction changes as may be reasonably required by the City. All Improvements shall be completed in accordance with all standards established in the applicable Codes, Ordinances, Resolutions, Rules and Regulations, all applicable laws and this Agreement, and in accordance with the grades, plans, and specifications approved by the City Engineer or his or her designee. Developer shall furnish two good and sufficient bonds, in an amount of 100% of the City Engineer's, or his or her designee's, estimated cost of the Improvements, guaranteeing Developer's performance of this Agreement: (1) a Payment Bond on a form provided by the City; and (2) a Faithful Performance Bond, both of which must be secured from a surety company admitted to do business in California. Each bond shall set forth a time period for performance by the Developer of its obligations and the terms and conditions on which the City may obtain the proceeds of the bond. Alternatively, the Developer may provide a cash deposit in an amount of 100% of the City Engineer's, or his or her designee's, estimated cost of the Improvements to guarantee Developer's performance of this Agreement.

The Faithful Performance Bond shall be in an amount not less than one hundred percent (100%) of the total estimated amount payable for the Improvements described in this Agreement, and shall secure payment to City of any loss due to the default of the Developer or its contractors or subcontractors their inability or refusal to perform this Agreement, and to guarantee or warranty the work done pursuant to this Agreement for a period of one year following acceptance thereof by City against any defective work or labor done or defective materials furnished. The Performance Bond shall by its terms remain in full force and effect for a period of not less than one year after completion of the Improvements by Developer and acceptance of the Improvements by the City, provided that after completion of the Improvements by the Developer and acceptance of the Improvements by the City, Developer may substitute for the Performance Bond securing the warranty described above with a separate warranty bond issued by an admitted surety in the amount of ten percent (10%) of the total contract price of the Improvements (provided that amount of said bond shall not be less than One Thousand Dollars (\$1,000) to cover the one-year warranty period).

The Payment Bond shall be in an amount not less than one hundred percent (100%) of the total estimated amount payable for the Improvements described in this Agreement. The Payment Bond shall secure the payment of those persons or entities to whom the Developer may become legally indebted for labor, materials, tools, equipment or services of any kind used or employed by the contractor or subcontractor in performing the work, or taxes or amounts to be withheld thereon. The Payment Bond shall provide that the surety will pay the following amounts should the Developer, or its contractor or subcontractors fail to pay the same, plus reasonable attorneys' fees to be fixed by the court if suit is brought upon the bond: (1) amounts due to any person that has a lien right pursuant to California Civil Code Sections 8520, 8530 and 9100; (2) amounts due under the Unemployment Insurance Code with respect to work or labor performed for the Improvements described in this Agreement; and (3) any amounts required to be deducted, withheld, and paid over to the Employment Development Department from the wages of employees of the Developer, its contractors and subcontractors pursuant to Section 13020 of the Unemployment Insurance Code with respect to the work and labor. The Payment Bond shall, by its terms, inure to the benefit of any person that has a lien right pursuant to Civil Code Sections 8520, 8530 and 9100 so as to give a right of action to those persons or their assigns in any suit brought upon the bond.

Developer shall file with the Recorder's Office of the County of Monterey a notice of completion of the Improvements in accordance with California Civil Code section 3093.

The Developer shall submit the following for both the surety that furnishes the Payment Bond and the surety that furnishes the Faithful Performance Bond: (1) a current printout from California Department of Insurances website (www.insurance.ca.gov) showing that the surety is admitted to do business in the State; or (2) a certificate from the Clerk of the County of Monterey that the surety's certificate of authority has not been surrendered, revoked, canceled, annulled, or suspended or in the event that it has, than renewed authority has been granted.

e. Any use by any person of the Improvements or any portion thereof, shall be at the sole and exclusive risk of Developer prior to City's acceptance of the Improvements. At all times during the term of this Agreement and until the Improvements constructed by Developer are accepted by City, Developer shall, at no cost to City obtain and maintain (1) a policy of general liability and

property damage insurance in the minimum amount of Two Million Dollars (\$2,000,000), combined single limit for both bodily injury and property damage; (2) workers' compensation insurance as required by law; and (3) broad form "Builder's Risk" property damage insurance limits of not less than 100% of the estimated value of the Improvements to be constructed by Developer pursuant to this Agreement (Builders Risk Insurance is not required when only mass grading and roadway- related improvements consisting of no structures are to be constructed).

Developer shall provide thirty (30) days written notice to City prior to termination, cancellation or modification of insurance. The insurance specified in (e) above shall (i) name City as additional insured, (ii) name City as a loss payee, and (iii) provide that City, although an additional insured or loss payee, may recover for any loss suffered by reason of the acts or omissions of Developer or Developer's contractors or subcontractors and shall be endorsed to waive all rights to recover against City for any loss or damage arising from a cause covered by the insurance required to be carried pursuant to this Agreement, and will cause each insurer to waive all rights of subrogation against City in connection therewith. All policies shall be written on an occurrence basis and not on a claims made basis and shall be issued by insurance companies acceptable to City. Prior to commencing any work pursuant this Agreement, Developer shall deliver to City the insurance company's certificate evidencing the required coverage, or if required by City a copy of the policies obtained. Not later than 30 days prior to policy expiration date on the current certificate of insurance, the Developer shall deliver to the City a new and updated certificate of insurance evidencing all required coverage remains in place.

Developer or its contractor(s) shall procure and maintain workers' compensation insurance with limits required by the California Labor Code and employer's liability insurance with limits of not less than \$1,000,000 per occurrence at all times during which the insured retains employees.

f. Developer shall pay to the City all fees, taxes and assessment imposed in connection with the Development and inspection of the Improvements including, but not limited to, plan check, design review, engineering, inspection, and other service fees and any impact of connection fees. These fees must be paid in full prior to the City's acceptance of the Improvements. The fees referred to above are not necessarily the only City fees, charges or other costs that have been, or will be, imposed on the Development and Improvements, and this Agreement shall in no way exonerate or relive the Developer from paying such other applicable fees, charges and/or cots.

SECTION 3

An estimate of the cost for construction of the Improvements and performing land development work in connection with the Improvements according to the Improvement Plans has been made and has been approved by the City Engineer or his or her designee. That estimated amount is Six Hundred Fifty Six Thousand Dollars (\$656,000). The basis for the estimate is on file in the Office of the City Engineer and is incorporated into this Agreement by reference.

SECTION 4

Developer will commence construction of the Improvements required by this Agreement within the time period set forth in the Schedule of Performance attached hereto as **Schedule 1** and incorporated herein by this reference (the "Schedule of Performance") between City and

Developer, as the Schedule of Performance may be subsequently amended in writing. All the provisions of this Agreement and all work to be done pursuant to the terms of this Agreement are to be completed within the time periods set forth in such Schedule of Performance. Developer shall maintain such public works facilities and other Improvements described in this Agreement at Developer's sole cost and expense at all times prior to acceptance by City in a manner which will preclude any hazard to life or health or damage to property. City agrees if it becomes necessary to allow Developer, by a prior writing signed by the Public Works Director, to keep streets closed to public traffic until the Improvements are accepted by the City and the bonds are released.

Improvement security may be released or reduced in the following manner:

- a. Improvement security given for faithful performance of the agreement may be released upon final completion and acceptance of the Improvements by the City; partial release of cash deposit Improvement security as the work progresses shall be as established hereinabove.
- b. Improvement security securing the payment to the Developer, its contractors and subcontractors, and to persons renting equipment or furnishing labor or materials may, six months after the completion and acceptance of the work, be reduced to an amount not less than the total of all claims on which an action has been filed and notice thereof given in writing to the City Council, and if there are no actions filed, the Improvement security may be released in full. City expressly may require the surety not to release the amount of security deemed necessary by the City to assure payment of reasonable expenses and fees, including reasonable attorney's fees.

SECTION 5

City shall not be responsible or liable for the maintenance or care of the Improvements until City approves and accepts them. City shall exercise no control over the Improvements until accepted by City. Any use by any person of the Improvements, or any portion thereof, shall be at the sole and exclusive risk of the Developer at all times prior to City's acceptance of the Improvements. Developer shall maintain all the Improvements in a state of good repair until they are completed by Developer and approved and accepted by the City, and until the security for the performance of this Agreement is released. Maintenance shall include, but shall not be limited to, repair of pavement, curbs, gutters, sidewalks, signals, parkways, water mains, and sewers; maintaining all landscaping in a vigorous and thriving condition reasonably acceptable to City; removal of debris from sewers and storm drains; and sweeping, repairing and maintaining in a good and safe condition all streets and street Improvements. It shall be Developer's responsibility to initiate all maintenance work, but if it shall fail to do so, it shall promptly perform such maintenance work when notified to do so by City. If Developer fails to properly prosecute its maintenance obligation under this Section, City may do all work necessary for such maintenance and the cost thereof shall be the responsibility of Developer and its surety under this Agreement. City shall not be responsible or liable for any damages or injury of any nature in any way related to or caused by the Improvements or their condition prior to acceptance.

SECTION 6

a) Default of Developer shall include, but not be limited to: (1) failure to timely commence construction of the Improvements; (2) failure to complete construction of the Improvements within the time limitations set forth in the Schedule of Performance; (3) failure to timely cure any

defect of the Improvements; (4) failure to perform substantial construction work on the Improvements for a period of sixty calendar days after commencement of the work; (5) Developer's insolvency, appointment of a receiver, or the filing of any petition in bankruptcy either voluntary or involuntary which Developer fails to discharge within thirty days; (6) commencement of a foreclosure action against the Development project or a portion thereof, or any conveyance in lieu or in avoidance of foreclosure; or (7) failure to perform any other obligation under this Agreement. Notwithstanding the foregoing, Developer shall not be in default under this Agreement if it cures any default within thirty days' of City's written notice of such default, or if the default may not reasonably be cured within such time period, if it commences to cure within thirty days and thereafter diligently proceeds to complete the cure.

- b) City reserves to itself all remedies available to it at law or in equity for breach of Developer's obligations under this Agreement. City shall have the right, subject to this Section, to draw upon or utilize the appropriate security to mitigate City's damages in the event of default by the Developer. The right of City to draw upon or utilize the security is additional to, and not in lieu of, any other remedy available to City. It is specifically recognized that the estimated costs and security amounts may not reflect the actual cost of construction or installation of the Improvements and, therefore, City's damages for Developer's default shall not exceed the cost of completing the Improvements. The sums provided by the security for the Improvements may be used by City for the completion of the Improvements in accordance with the Improvement Plans referenced herein.
- c) In the event of Developer's default under this Agreement, Developer authorizes City to perform such obligation sixty days after mailing written notice of default to Developer and to Developer's surety, and agrees to pay the entire cost of such performance by City. City may take over the work and prosecute the same to completion by contract or by any other method City may deem advisable, for the account and at the expense of Developer, and Developer's surety shall be liable to the City for any excess cost or damages occasioned City thereby, including but not limited to fees and charges of architects, engineers, attorneys, other professionals and court costs. In such event, City, without liability for doing so, may take possession of, and utilize in completing the work, such materials, appliances, plants and other property belonging to Developer as may be on the site of the work and necessary for performance of the work.
- d) Failure of City to take an enforcement action with respect to a default, or to declare a breach, shall not be construed as a waiver of that default or breach or any subsequent default or breach of Developer.

SECTION 7

That the following General Stipulations and any attached stipulations shall be completed, subject to the approval of the Public Works Director.

- a. Locate and properly dispose of any wells, septic tanks and underground fuel storage facilities.
- b. Schedule the construction of Improvements along existing public roads so that the work affecting vehicular traffic is complete with a minimum interruption of traffic.

- c. All work within the public right-of-way shall be subject to the approval of the Public Works Director or his or her designee.
- d. All construction work shall be coordinated so that the existing residents and/or businesses have access to their properties.
- e. All Improvements shall be installed per the approved Improvement Plans.
- f. The Developer shall provide to the City electronic copy of the "as built" and Improvement Plans as an AutoCAD drawing file (DWG format, latest AutoCAD edition).
- g. Any reimbursements due the Developer, unless specified otherwise in writing in this Agreement, will expire ten (10) years after the date of execution of this Agreement.
- h. Until the roads on the Property are open to the public, Developer shall give good and adequate warning to the public of each and every dangerous condition on the existing public roads, and will take all reasonable actions to protect the public from such dangerous condition.
- Prior to the acceptance of any dedications or Improvements by City, Developer shall certify i. and warrant that neither the Improvements nor Developer is in violation of any environmental law and neither the Improvements nor the Developer is subject to any existing, pending or threatened investigation by any federal, state or local governmental authority under or in connection with environmental law. Neither Developer nor any third party will use, generate, manufacture, produce, or release, on, under, or about the Improvements, any hazardous substance except in compliance with all applicable environmental laws. Developer has not caused or permitted the release of, and has no knowledge of the release or presence of, any hazardous substance on the Improvements or the migration of any hazardous substance from or to any other property adjacent to, or in the vicinity of, the Improvements. Developer's prior and present use of the Property and Improvements has not resulted in the release of any hazardous substance on the Improvements. Developer shall give prompt written notice to City at the address set forth herein of: (i) Any proceeding or investigation by any federal, state or local governmental authority with respect to the presence of any hazardous substance on the Improvements or the migration thereof from or to any other property adjacent to, or in the vicinity of, Improvements; (ii) Any claims made or threatened by any third party against City or the Improvements relating to any loss or injury resulting from any hazardous substance; and, (iii) Developer's discovery of any occurrence or condition on any property adjoining in the vicinity of the Improvements that could cause the Improvements or any part thereof to be subject to any restrictions on its ownership, occupancy, use for the purpose for which is it is intended, transferability or suit under any environmental law.

SECTION 8

Developer shall, at Developer's expense, obtain all necessary permits and licenses for the construction and installation of the Improvements, give all necessary notices and pay all fees and taxes required by law.

SECTION 9

Neither Developer nor any of Developer's agents, contractors or subcontractors are or shall be considered to be agents of City in connection with the performance of Developer's obligations under this Agreement.

SECTION 10

Nothing contained in this Agreement shall preclude City from expending monies pursuant to agreements concurrently or previously executed between the parties, or from entering into agreements with other developers for the apportionment of costs of water and sewer mains, or other improvements, pursuant to the provisions of the City ordinance providing therefor, nor shall anything in this Agreement commit the City to any such apportionment.

SECTION 11

Developer shall not be entitled to assign its obligations under this Agreement to any transferee of all or any part of the property within the Improvements or to any other third party without the express written consent of City.

SECTION 12

Acceptance of the work, or any portion of the work on behalf of the City shall be made by the City Council upon recommendation of the City Engineer after final completion and inspection of all Improvements and payment to the City by the Developer for the cost of all inspections. Such acceptance shall not constitute a waiver of defects by City. The City shall recover all inspection costs.

SECTION 13

The provisions of this Agreement are severable. If any portion of this Agreement is held invalid by a court of competent jurisdiction, the remainder of the Agreement shall remain in full force and effect unless amended or modified by the mutual consent of the parties.

SECTION 14

In the event that suit or arbitration is brought to enforce the terms of this Agreement, the prevailing party shall be entitled to litigation costs and reasonable attorney's fees.

SECTION 15

This Agreement shall be interpreted in accordance with the laws of the State of California. Jurisdiction of all disputes of this Agreement shall be in the County of Monterey, State of California.

SECTION 16

Time is of the essence of this Agreement.

SECTION 17

This Agreement constitutes the entire agreement of the parties with respect to the subject matter. All modifications, amendments or waivers of the terms of this Agreement must be in writing and signed by an authorized representative of the parties.

SECTION 18

In the event the Schedule of Performance (including any Conforming Clarifications thereto) is tolled, the time for commencement of construction or completion of the Improvements hereunder shall be extended for the same duration as applies to the Schedule of Performance. Any such extension may be granted without notice to Developer's surety and shall not affect the validity of this Agreement or release the surety on any security given for this Agreement.

SECTION 19

The Parties hereby mutually agree that neither this Agreement, nor any other related entitlement, permit or approval issued by the City for the Development or Improvements shall operate to create the relationship of partnership, joint venture, or agency between City and Developer. Developer's contractors and subcontractors are exclusively and solely under the control and dominion of Developer, Nothing herein shall be deemed to make Developer or its contractors or subcontractors an agent or contractor of the City.

SECTION 20

All notices, demands, invoices and written determinations shall be in writing and delivered to the following addresses, or such other addresses as the Parties may designate by written notice:

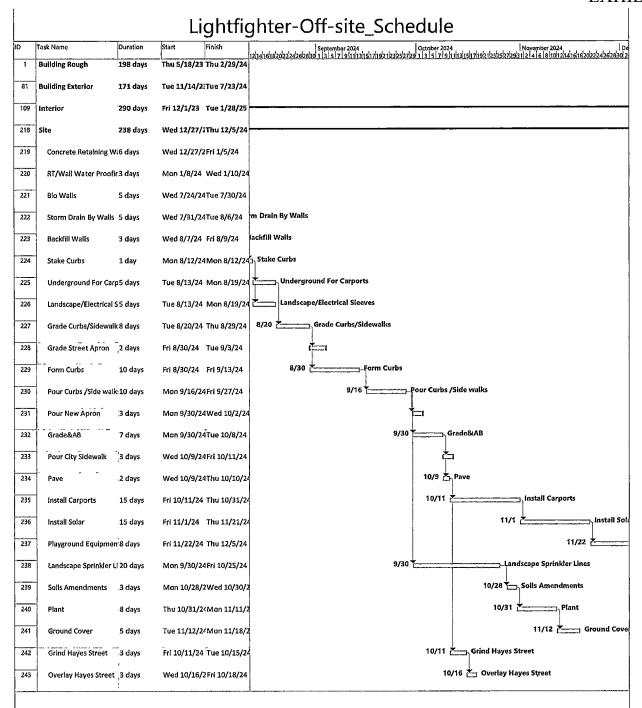

HIGHLIGHTS OF REGULAR BOARD MEETING February 20, 2025

1. Mary Ann Carbone, Board Chair, called the meeting to order at 11:08 a.m. at City Hall in Sand City.

- 2. The Board approved routine consent items, including minutes of the January 16, 2025 Board meeting and disbursements for the period of January 1-31, 2025 in the amount of \$1,662,010.78.
- 3. From the CEO report:
 - Total donations for January 2025: \$17,760 from 62 donors and 8 in-kind donations. Most of the in-kind donations were for a client who just moved out of Safe Passage into permanent housing.
 - Significant donations were as follows:
 - \$10,000 for Shuman HeartHouse (SHH)
 - \$1.000 unrestricted
 - \$925 unrestricted, via a nurse practitioner at CHOMP who collected donations for CHS at his house party.
 - Bombas donated 3,000 pairs of socks which were delivered to Shuman HeartHouse, Casa de Noche Buena (CDNB), the SHARE Center, Safe Place Salinas and Monterey, Safe Passage, and Salinas Valley Street Outreach Program for distribution to individuals experiencing homelessness.









- Grant applications were submitted to:
 - Pebble Beach Company Foundation, \$10,000 for CDNB
 - Yellow Brick Road, \$10,000 for SHH
 - William G. Irwin Charity Foundation, \$111,839 for Family Service Center facilities improvements
 - Stevenson School Philanthropy Project, \$10,000-\$12,000 to support outreach and marketing costs for the new youth outpatient SUD program
- A fundraising event will take place on Saturday, April 12, from 12-6 pm at the Sand City Art Park—"Banding Together: A Jamfest to Support Mental Health, Substance Abuse, and Homeless Services." Suggested donation \$30.
- We continue to interview for vacant Senior Program Officer of Mental Health Services and Development Director positions.
- "Solving Homelessness: A Community Conversation" will take place on April 24th from 2-4pm at MIIS Irvine Auditorium, featuring Kevin Adler, author of "When We Walk By," who will speak on stigma, broken systems that contribute to homelessness and what we can do.

- The CEO, CFO & COO worked on FY 25-26 projected budget for the SHARE Center at the request of the City and County. This is a very preliminary look at funding needs for next year and subject to change by all parties.
- Currently serval notable construction projects are underway: The Genesis House Bathroom Improvements project and The Safe Passage Facility Improvements Project.

4. From the COO report:

- The SHARE Center is doing well and is now fully staffed. We have resumed intakes and are currently serving 70 guests, scheduling 4 intakes per day to reach full capacity. SHARE Center is participating in the Inclement Weather Program, offering emergency shelter beds when the County of Monterey declares inclement weather.
- Process is being made to expand Off Main Clinic services into the neighboring Outpatient Drug Treatment Program.
- 5. The Finance Committee meeting was held earlier in the day. Financial reports were provided in the board packet for review.
- 6. The Board provisionally approved a resolution authorizing the Agency to establish a \$1 million line of credit with Pinnacle Bank with defined terms.
- 7. The board approved the Family Service Center Seaside Mainline Pluming Project with JD Underground's bid, not to exceed \$40K.
- 8. Board Member Annette Yee Steck shared MCOE's Annual Education Report in both English and Spanish by email.
- 9. Board Members and CEO Robin McCrae went into a closed session to conference with legal counsel regarding anticipated litigation. No action was taken.
- 10. Board Chair Mary Ann Carbone adjourned the meeting at 1:23p.m.

The next regular board meeting is scheduled for Thursday, March 20th from 11:00 a.m. to 1:00 p.m. at the Sand City City Hall, Sand City, CA.

ORDINANCE NO. 2025-02

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MARINA AMENDING ORDINANCES NOS. 90-8, 86-6, 85-3, AND 79-12 TO REVISE THE COMPENSATION FOR MAYOR AND COUNCILMEMBERS

WHEREAS, the compensation for the mayor and city councilmembers was last increased over 34 years ago on September 4, 1990; and

WHEREAS, since that time, the cost of living alone has increased more than 300%; and

WHEREAS, as the city has grown in population and complexity, the hours required, and resources needed to prepare for and attend city council meetings and perform other functions of the city council have increased significantly; and

WHEREAS, the current salary for the mayor is set at \$250 per month and a city councilmember at \$200 per month; these salaries are some of the lowest in the Monterey County area; and

WHEREAS, the California Legislature recognized the low compensation for members of city councils as a problem in 2023 and adopted Senate Bill 329 (Dodd) which authorized general law cities to enact an ordinance to increase compensation for each member of a city council based upon the population and authorized that amount to be increased by up to 5% for each calendar year from the operative date of the last adjustment; and

WHEREAS, although the City of Marina is not a general law city and thus SB 329 is not applicable, the goal of the bill was to address inflationary increases and economic realities and remove barriers to achieving more equitable representation in local government by making it easier for public servants to balance careers and personal obligations; and

WHERAS, the intent of SB 329 was to assist city councils in become more diverse because increased compensation can help individuals from across different income levels receive sufficient income from their service to help ensure that they can continue to serve the public and support their families making it easier for members of marginalized communities to serve;

WHEREAS, the City Council of the City of Marina finds that, consistent with the findings of SB 329, increasing the compensation for it councilmembers would facilitate equitable representation in local government by making it easier for public servants to balance careers and personal obligations, and increase the opportunity for individuals across different income levels, as well as those individuals in marginalized communities, to participate in public service; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MARINA DOES ORDAIN AS FOLLOWS:

1. Ordinance Nos. 90-8, 86-6, 85-3, and 79-12 Amended. Ordinance No. 90-8, adopted on September 4, 1990, Ordinance No. 86-6, adopted on May 6, 1986, Ordinance No. 85-3, adopted on May 21, 1985, and Ordinance No. 79-12, adopted on September 26, 1979, all of which relate to the compensation for Mayor and Councilmembers, are hereby amended to read in their entirety as follows:

Ordinance No. 2025-02 Page Two

- a. <u>Compensation</u>. Each Councilmember shall receive compensation of \$2,000 per month, and the directly elected Mayor shall receive compensation of \$2,250 per month.
- b. <u>Cost of Living Adjustments</u>. Compensation stipend shall be adjusted annually, according to the cost of living adjustment approved for the City's general bargaining unit employees..
- c. <u>Reimbursement</u>. Mayor and Council members are eligible for reimbursement for official travel according to Resolution 97-38 and the policies and procedures set forth in the official travel policy.
- d. <u>Benefits</u>. Mayor and Council members are eligible to enroll in current available plans offered by the City for Health, Dental and Vision at their own costs; no city contribution. Mayor and Council may divert their compensation stipend set forth in 1.a. to cover the costs of benefit elections.
- e. <u>Effective Date.</u> This ordinance shall take effect and be in force 30 days after adoption.
- 2. <u>Posting of Ordinance</u>. Within fifteen (15) days after the passage of this ordinance, the City Clerk shall cause it to be posted in the three public places designated by resolution of the City Council.

CITY COUNCIL CONSIDER INTRODUCING ORDINANCE NO. 2025-, AMENDING THE MARINA MUNICIPAL CODE (MMC), CHAPTER 17, ARTICLE 6, BY ADDING TWO (2) NEW SECTIONS 17.59 - "COMMUNITY DEVELOPMENT DIRECTOR'S DISCRETION" AND 17.69 - "PERMIT EXPIRATION", AND AMENDING SECTIONS 17.56, 17.58, 17.60, AND 17.70 PERTAINING TO APPEALS. THE PROPOSED ORDINANCE IS EXEMPT FROM ENVIRONMENTAL REVIEW PERSUANT TO SECTION 15061 (b)(3) OF THE CEQA GUIDELINES.

RECOMMENDATION: It is recommended that the City Council consider:

- 1. Introducing Ordinance No. 2025-, amending Title 17, Article 6, by adding new Sections 17.59 and 17.69, and amending Sections 17.56, 17.58, 17.60, and 17.70 of the Marina Municipal Code pertaining to the Administration of this Title.
- 2. Finding this action is exempt from environmental review pursuant to Section 15061(B)(3) of the CEQA Guidelines.

BACKGROUND

On January 23, 2025, the Marina Planning Commission held a public hearing at which staff presented and received input from the Commission on the proposed amendments to Title 17, Article 6 pertaining to Extension, Appeal, and Staff Transparency, by adding new Sections 17.59 and 17.69, and amending Sections 17.56, 17.58, 17.60, and 17.70 of the Marina Municipal Code. The Planning Commission provided valuable feedback which was incorporated into the draft ordinance. The Planning Commission approved Resolution 2025-02 that recommended the City Council adopt changes to Chapter 17 of the Marina Municipal Code as described in the draft ordinance (**EXHIBIT A**).

ANALYSIS

Through regular use and implementation of Title 17 of the Marina Municipal Code (MMC), planning staff has found that several standard procedural measures within the MMC could benefit from greater clarity. As one example, the MMC currently does not have a transparent procedure for permit extensions. Currently, permit extensions are done on an ad-hoc basis. This amendment proposes to add a section that clearly describes the procedure to obtain an extension of time for a permit should a project take longer than anticipated to commence. A brief description of the proposed amendments follows:

- 1. Addition of a new section (MMC Sec. 17.59) that allows the Community Development Director (Director) to require that a permit that may be granted through an administrative process be reviewed instead by the Planning Commission in cases where the Director finds that additional transparency and public participation would be beneficial;
- 2. Addition of a new section (MMC Sec. 17.69) that establishes clear standards on permit effective dates and expiration timeframes. The proposed language allows for the lifespan of an approved permit to be two (2) years instead of one (1) year and clearly states that the Director is the review authority for all extensions. It also clarifies that the number of extensions allowed is two (2) one (1) year extensions; and

3. Repeal of MMC Sections 17.56.060, 17.58.050, 17.60.060 concerning different appeal procedures for different permits, and modification of Sec. 17.70 so that all the appeal procedures will be standardized and centralized into one location for all permits. Proposed new Sec. 17.70.030 adds a requirement that an appeal of a Planning Commission action include a statement or evidence specifying an error or abuse of discretion by the Commission or that the Planning Commission's decision is not supported by substantial evidence in the record. Although clearly required by case law for the sustaining of an appeal, the current MMC does not specify such requirement. Spelling out this requirement gives greater transparency to those wishing to appeal a Planning Commission action. Note that appeal *fees* are not part of the MMC but are instead adopted separately by the City Council by Resolution. The most recent fee schedule was adopted on September 1, 2024 (Council Reso. 2024-86).

The adoption of these procedural standards will help to clarify important processes for both City staff and the general public. This item was considered at a noticed public hearing of the Planning Commission on January 23, 2025. The Planning Commission adopted Resolution 2025-02 (**EXHIBIT B**) recommending that the Council approve the proposed amendment with a minor change to proposed MMC Sec. 17.59.010 specifying the Planning Commission as the "higher authority".

FISCAL IMPACT

There is no fiscal impact.

ENVIRONMENTAL REVIEW

The proposed project is exempt from the California Environmental Quality Act (CEQA) under Section 15061(b)(3) of the State CEQA Guidelines. Staff has determined that the exemption applies in this case because the proposed procedural changes would not result in a direct or a reasonably foreseeable indirect physical change in the environment and the proposed ordinance is covered by the general rule that CEQA applies only to projects which have potential for causing significant effect on the environment. Therefore, the adoption of this ordinance is exempt from CEQA, and no further environmental review is necessary.

CONCLUSION

This request is submitted for City Council consideration and action.

THE CITY COUNCIL OF THE CITY OF MARINA DOES HEREBY ORDAIN AS FOLLOWS:

- 1. The Community Development Dept. (CDD) of the City of Marina (City), through its regular use and implementation of the Marina Municipal Code (MMC), finds that several standard procedural measures should be amended for greater clarity. The proposed amendments include:
 - a. The addition of MMC Sec. 17.59 to give the Community Development Director
 (Director) the discretion to require a permit to be reviewed by the Planning
 Commission if this action will increase the transparency and public participation in
 the review of the permit;
 - b. The addition of MMC Sec. 17.69 establishing clear standards on permit effective dates, expiration timeframes, and extensions; and

Chapter 17, Article 6, entitled "Administration, Enforcement and Penalties" is hereby amended by adding two (2) new Sections, Sec. 17.59 "Community Development Director's Discretion", and Sec. 17.69, entitled "Permit Expiration", and amending Sections 17.56, 17.58, 17.60, and 17.70 relating to appeals procedures, to the Marina Municipal Code to read as set forth on the attached **Exhibit A** and incorporated herein by this reference thereto.

- 4. Section 17.70 Appeals. This chapter will become the central location for regulations pertaining to appeals outside of the Coastal zone. The individual chapters pertaining to individual permit types will no longer include sections on appeals. Appeals of projects that are located in the Coastal zone will continue to be governed by MMC 17.40.280.
- 5. Environmental. The proposed Ordinance amendments are not subject to environmental review pursuant to the State CEQA Guidelines, California Code of Regulations, Title 14, Article 5, Section 15061(b)(3) because the proposed procedural changes would not result in a direct or a reasonably foreseeable indirect physical change in the environment and the proposed ordinance is covered by the general rule that CEQA applies only to projects which have potential for causing significant effect on the environment. Therefore, the adoption of this ordinance is exempt from CEQA, and no further environmental review is necessary.
- 6. Effective Date. This Ordinance shall be in full force and effect on thirty (30) days after its final passage and adoption.
- 7. Severability. If any portion of this Ordinance is found to be unconstitutional or invalid the City Council hereby declares that it would have enacted the remainder of this Ordinance regardless of the absence of any such invalid part.
- 8. Posting of Ordinance. Within fifteen (15) days after the passage of this Ordinance, the City Clerk shall cause it to be posted in the three (3) public places designated by resolution of the City Council.

COMMUNITY DEVELOPMENT DIRECTOR'S DISCRETION

17.59.010 Purpose.

The purpose of this chapter is to clarify the Community Development Director's discretion in the interest of the public; the Director shall be granted the ability to require a review of a permit by the Planning Commission. This discretion is to increase transparency and public participation in the permit review process for items deemed to be in the public interest or having broad effect on the community.

17.59.020 Directors Discretion.

The Director may defer an administrative action and refer the item to the Planning Commission for decision.

17.59.030 Director Appeal Authority.

The Director may defer a request for a determination to the Planning Commission, thus making the City Council the appeal authority.

Chapter 17.69

PERMIT EXPIRATION

Sections:

17.69.010 Purpose.

17.69.020 Effective date of permits.

17.69.030 Performance guarantees.

17.69.040 Time Limits and extensions.

17.69.050 Permits to run with the land.

17.69.060 Resubmittals.

17.69.010 Purpose.

This chapter provides requirements for the implementation or exercising of the permits required by these regulations, including time limits and procedures for extensions of time.

17.69.020 Effective date of permits.

The approval of community development permits shall become effective on the eleventh day following the date of approval by the appropriate review authority, where no appeal of the review authority's action has been filed in compliance with Chapter 17.70 MMC (Appeals).

17.69.030 Time limits and extensions.

- (A) Expiration. Any community development permit granted in compliance with these regulations shall expire within two (2) years from the date of approval if neither a completed building permit application has been issued nor the activity authorized by the community development permit has commenced. Upon expiration or revocation of a building permit, the community development permit shall also expire, unless extended under subsection (B) of this section.
- (B) Extensions of Time by Community Development Director (Director) or Designee. The Director is authorized to renew any community development permit that would otherwise expire after two (2) years. Renewals shall be for one (1) year with a maximum of two (2) renewals.
- (C) Action on Extension Requests. An application for a time extension shall be made a minimum of thirty (30) business days prior to the permit expiration date.

17.69.040 Permits to run with the land.

A community development permit granted in compliance with this chapter shall continue to be valid upon a change of ownership (e.g., of the site, structure, or use that was the subject of the permit application); provided, that the use remains in compliance with all applicable provisions of these regulations and any conditions of approval.

17.69.050 Resubmittals.

If an application for a community development permit is denied in compliance with this chapter, an application for consideration of an identical or similar request shall not be eligible for reconsideration for six months from the date on which the denial became final, unless the review authority finds that changed circumstances or a material change in the application warrants reconsideration prior to the expiration of six months. This section shall have no effect on applications by the City or on amendments proposed by resolutions of the City Council or the Planning Commission.

SITE AND ARCHITECTURAL DESIGN REVIEW

17.56.060 Appeal. [repealed]

A. If the applicant or any person who has participated in the process by personal attendance at meetings, testimony at meetings or other reasonable means is not satisfied with the action of the planning commission, said person may file an appeal with the city council in writing within ten days after written notice of the decision of the planning commission has been mailed to the applicant. The appeal shall set forth specifically the points of issue, the reason for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the appropriate authority. The city council shall hold a hearing on said appeal and shall render its decision thereon within thirty days after filing thereof. The city council may reverse or affirm or modify the decision of the planning commission and such action shall be final.

B. If the applicant or any person who has participated in the process by personal attendance at meetings, testimony at meetings or other reasonable means is not satisfied with the action of the design review board relative to final design review, or the decision of the planning director or the design review board with respect to any proposed plan modification, said individual may file an appeal with the city clerk in writing within ten days after the said action or decision. The appeal shall set forth specifically the points of issue, the reason for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the appropriate authority. The appeal shall be considered by the planning commission unless the city council granted design review approval on appeal, in which case the appeal shall be considered by the city council. Said appeal body shall hold a hearing on said appeal and shall render its decision thereon within thirty days after filing thereof. Said body may reverse or affirm or modify the decision of the design review board or the decision or interpretation of the planning director and such action shall be final.

17.58.050 Appeal. [repealed]

A. An appeal to the city council may be filed by any person aggrieved by a decision of the appropriate authority. Such appeal shall be in writing and shall be filed with the city clerk within ten days after written notice of the decision has been mailed to the applicant. At the time of the filing of the appeal, the appellant shall pay a filing fee to be established by resolution of the city council from time to time hereafter enacted. An appeal shall set forth specifically the points at issue, the reasons for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the appropriate authority.

B. Upon receipt of the notice of appeal, the city council shall set a date for public hearing thereon, giving notice thereof pursuant to Section <u>17.58.030</u>. 17.60.060 Appeal. [repealed]

A. An appeal to the city council may be filed by any person aggrieved by a decision of the planning commission. Such appeal shall be in writing and shall be filed with the city clerk within ten days after written notice of the decision has been mailed to the applicant. At the time of the filing of the appeal, the appellant other than the applicant shall pay a filing fee to be established by resolution of the city council from time to time hereafter enacted. An appeal shall set forth specifically the points at issue, the reasons for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the planning commission.

B. Upon receipt of the notice of appeal, the city council shall set a date for public hearing thereon, giving notice thereof pursuant to Section <u>17.60.040</u>. The city council may reverse or affirm, wholly or partly, or may modify the order, requirement, decision or determination appealed from, and may make such order, requirement, decision or determination as should be made, and such action shall be final.

17.70.010 - Planning commission authority Purpose.

17.70.010 Purpose.

Determinations or actions of the Community Development Director or his/her designee, or planning commission may be appealed by this chapter.

17.70.020 Appeal subjects and appeal authority.

Determinations and actions that may be appealed, and the authority to act upon an appeal, shall be as follows:

- (A) Staff Determinations. The following determinations and actions of the community development director or his/her designee may be appealed to the planning commission and then to the council.
 - (1) Director's Determinations on the meaning or applicability of these regulations that are believed to be in error.

(B) Decisions of Review Authorities. Generally, decisions of the Director and the Tree Committee may be appealed to the Planning Commission, and decisions of the Planning Commission may be appealed to the council. When a single project requires two or more permit applications with different appeal authorities, or where statutory deadlines would interfere with the City's final action on an application if the application were subject to multiple appeals, any appeal of the project shall go directly to the highest appeal authority. The decision of the City Council shall be final. If an appeal is filed for a project that utilized the City's Objective Design Standards for a housing development project as defined by California Government Code 65589.5, the appeal must be based on identifying an inconsistency with an objective standard that is consistent with state law and filed with the City during the standard appeal period for a development project.

17.70.030 Filing of Appeals.

- (A) Who May File an Appeal. An appeal may be filed by:
 - (1) Any person aggrieved by an administrative determination or action by the department; or
 - (2) Anyone who, in person or through an authorized representative, appeared at a public hearing in connection with the decision being appealed, or who otherwise informed the City in writing of the nature of their concerns before the hearing.
- (B) Timing and Form of Appeal. All appeals shall be submitted in writing on a City application and shall specifically state the pertinent facts of the case and the basis for the appeal.
 - (1) Appeals shall be filed in the community development department or, in the case of appeals of Planning Commission actions, in the office of the city clerk, within 10 calendar days following the final date of the determination or action being appealed.
 - (2) Appeals shall be accompanied by a written report stating specifically wherein it is claimed there was an error or abuse of discretion by the Commission or wherein its decision is not supported by substantial evidence in the record. The Council shall only hear the appeal if the notice is filed and all required fees are paid within the ten (10) calendar day appeal period. An appellant may submit a written request to withdraw their appeal any time before the scheduled hearing for the appeal.
- (C) Scope of Appeals. An appeal of a decision on a community development permit shall be limited to issues raised at the public hearing, or in writing before the hearing, or, in all other cases, must be based on information that was not generally known at the time of the decision that is being appealed.

17.70.040 Processing of Appeals.

- (A) Scheduling of Hearing. After an appeal has been received, the matter shall be placed on the next available agenda of the appeal authority that is within sixty (60) days of the filing of such appeal.
- (B) Notification of Applicant. Within three (3) business days of receipt of an appeal, staff shall attempt to notify the applicant.

- (C) Joining an Appeal. Only those persons who file an appeal within the time limit established shall be considered appellants. Any person who wishes to join an appeal shall follow the same procedures for an appellant. No person shall be allowed to join an appeal after the expiration of the time limit for appeals.
- (D) Action and Findings. The appeal authority shall conduct a *de novo* public hearing. At the hearing, the appeal authority may consider any issue involving the matter that is the subject of the appeal, in addition to the specific grounds identified in the appeal.
 - (1) The appeal authority may affirm, affirm in part, or reverse the action, decision, or determination that is the subject of the appeal, based upon findings of fact about the case. The findings shall identify the reasons for the action on the appeal and verify the compliance or non-compliance of the subject of the appeal with these regulations.
 - (2) When reviewing a decision on a community development permit, the appeal authority may adopt additional conditions of approval that may address other issues or concerns than the subject of the appeal.
 - (3) Effective Date of Appeal. A decision by any appeal authority other than the City Council is effective on the eleventh day after the decision, if no appeal to the decision has been filed, or before the next regularly scheduled meeting. Because a decision by the City Council is final, it is effective as of the date of the decision, unless the Council specifies an alternative date.

WHEREAS, the proposed amendments to Chapter 17 of the MMC are included in the draft ordinance referenced herein as Exhibit A;

WHEREAS, the findings and conclusions made by the City Council in this resolution are based upon the oral and written evidence presented as well as the entirety of the administrative record for the proposed amendment, which is incorporated herein by this reference. The findings are not based solely on the information provided in this resolution;

WHEREAS, the project is exempt from CEQA per Section 15061(b)(3) because the proposed procedural changes would not result in a direct or a reasonably foreseeable indirect physical change in the environment and the proposed ordinance is covered by the general rule that CEQA applies only to projects which have potential for causing significant effect on the environment.

NOW THEREFORE BE IT RESOLVED that the Planning Commission does hereby recommend that the City Council adopt changes to Chapter 17 of the Marina Municipal Code as described in the draft ordinance referenced herein as Exhibit A.

AN ORDINANCE AMENDING THE MARINA MUNICIPAL CODE (MMC), CHAPTER 17, ARTICLE 6, BY ADDING TWO (2) NEW SECTIONS 17.59 - "COMMUNITY DEVELOPMENT DIRECTOR'S DISCRETION" AND 17.69 - "PERMIT EXPIRATION", AND AMENDING SECTIONS 17.56, 17.58, 17.60, AND 17.70 PERTAINING TO APPEALS. THE PROPOSED ORDINANCE IS EXEMPT FROM ENVIRONMENTAL REVIEW PERSUANT TO SECTION 15061(b)(3) OF THE CEQA GUIDELINES.

THE CITY COUNCIL OF THE CITY OF MARINA DOES HEREBY ORDAIN AS FOLLOWS:

- 1. The Community Development Dept. (CDD) of the City of Marina (City), through its regular use and implementation of the Marina Municipal Code (MMC), finds that several standard procedural measures should be amended for clarity. The proposed amendments include:
 - a. The addition of MMC Sec. 17.59 to give the Community Development Director
 (Director) the discretion to require a permit to be reviewed by the Planning
 Commission if this action will increase the transparency and public participation in the review of the permit;
 - b. The addition of MMC Sec. 17.69 establishing clear standards on permit effective dates and expiration timeframes; and
 - c. Modifying MMC Sections 17.56, 17.58, 17.60, and 17.70 providing a standardized appeal process that applies to both the appeal of a Director's Determination as well as to appeals of actions made by the Planning Commission.
- 2. The adoption of these procedural standards will clarify important processes for both City staff and the general public.
- 3. Chapter 17, Article 6. Chapter 17, Article 6, entitled "Administration, Enforcement and Penalties" is hereby amended by adding two (2) new Sections, Sec. 17.59 "Community

Development Director's Discretion", and Sec. 17.69, entitled "Permit Expiration", and amending Sections 17.56, 17.58, 17.60, and 17.70 relating to appeals procedures, to the Marina Municipal Code to read as set forth on the attached **Exhibit A** and incorporated herein by this reference thereto.

- 4. Section 17.70 Appeals. This chapter will become the central location for regulations pertaining to appeals outside of the Coastal zone. The individual chapters pertaining to individual permit types will no longer include sections on appeals. Appeals of projects that are located in the Coastal zone will continue to be governed by MMC 17.40.280.
- 5. Environmental. The proposed Ordinance amendments are not subject to environmental review pursuant to the State CEQA Guidelines, California Code of Regulations, Title 14, Article 5, Section 15061(b)(3) because the proposed procedural changes would not result in a direct or a reasonably foreseeable indirect physical change in the environment and the proposed ordinance is covered by the general rule that CEQA applies only to projects which have potential for causing significant effect on the environment. Therefore, the adoption of this ordinance is exempt from CEQA, and no further environmental review is necessary.
- 6. Effective Date. This Ordinance shall be in full force and effect on thirty (30) days after its final passage and adoption.
- 7. Severability. If any portion of this Ordinance is found to be unconstitutional or invalid the City Council hereby declares that it would have enacted the remainder of this Ordinance regardless of the absence of any such invalid part.
- 8. Posting of Ordinance. Within fifteen (15) days after the passage of this Ordinance, the City Clerk shall cause it to be posted in the three (3) public places designated by resolution of the City Council.

Chapter 17.59 COMMUNITY DEVELOPMENT DIRECTOR'S DISCRETION

Sections:

17.59.010 Purpose.

17.59.020 Directors Discretion.

17.59.030 Director Appeal Authority.

17.59.010 Purpose.

The purpose of this chapter is to clarify the Community Development Director's discretion in the interest of the public; the Director shall be granted the ability to require a review of a permit by the Planning Commission. This discretion is to increase transparency and public participation in the permit review process for items deemed to be in the public interest or having broad effect on the community.

17.59.020 Directors Discretion.

The Director may defer an administrative action and refer the item to the Planning Commission for decision.

17.59.030 Director Appeal Authority.

The Director may defer a request for a determination and, thereby, the applicable appeal authority, to the first appeal authority for decision.

Chapter 17.69 PERMIT EXPIRATION

Sections:

17.69.010 Purpose.

17.69.020 Effective date of permits.

17.69.030 Performance guarantees.

17.69.040 Time Limits and extensions.

17.69.050 Permits to run with the land.

17.69.060 Resubmittals.

17.69.010 Purpose.

This chapter provides requirements for the implementation or exercising of the permits required by these regulations, including time limits and procedures for extensions of time.

17.69.020 Effective date of permits.

The approval of the community development permits shall become effective on the eleventh day following the date of approval by the appropriate review authority, where no appeal of the review authority's action has been filed in compliance with Chapter 17.70 MMC (Appeals).

17.69.030 Time limits and extensions.

- (A) Expiration. Any community development permit granted in compliance with these regulations shall expire within two (2) years from the date of approval if neither a completed building permit application has been issued nor the activity authorized by the community development permit has commenced. Upon expiration or revocation of a building permit, the community development permit shall also expire, unless extended under subsection (B) of this section.
- (B) Extensions of Time by Community Development Director (Director) or Designee. The Director is authorized to renew any community development permit that would otherwise expire after two (2) years. Renewals shall be for one (1) year with a maximum of two (2) renewals.
- (C) Action on Extension Requests. An application for a time extension shall be made a minimum of thirty (30) business days prior to the permit expiration date.

17.69.040 Permits to run with the land.

A community development permit granted in compliance with this chapter shall continue to be valid upon a change of ownership (e.g., of the site, structure, or use that was the subject of the permit application); provided, that the use remains in compliance with all applicable provisions of these regulations and any conditions of approval.

17.69.050 Resubmittals.

If an application for a community development permit is disapproved in compliance with this chapter, an application for consideration of an identical or similar request shall not be eligible for reconsideration for six months from the date on which the disapproval became final, unless the review authority finds that changed circumstances or a material change in the application warrants reconsideration prior to the expiration of six months. This section shall have no effect on applications by the City or on amendments proposed by resolutions of the City Council or the Planning Commission.

Chapter 17.56 SITE AND ARCHITECTURAL DESIGN REVIEW

17.56.060 Appeal. [repealed]

A. If the applicant or any person who has participated in the process by personal attendance at meetings, testimony at meetings or other reasonable means is not satisfied with the action of the

planning commission, said person may file an appeal with the city council in writing within ten days after written notice of the decision of the planning commission has been mailed to the applicant. The appeal shall set forth specifically the points of issue, the reason for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the appropriate authority. The city council shall hold a hearing on said appeal and shall render its decision thereon within thirty days after filing thereof. The city council may reverse or affirm or modify the decision of the planning commission and such action shall be final.

B. If the applicant or any person who has participated in the process by personal attendance at meetings, testimony at meetings or other reasonable means is not satisfied with the action of the design review board relative to final design review, or the decision of the planning director or the design review board with respect to any proposed plan modification, said individual may file an appeal with the city clerk in writing within ten days after the said action or decision. The appeal shall set forth specifically the points of issue, the reason for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the appropriate authority. The appeal shall be considered by the planning commission unless the city council granted design review approval on appeal, in which case the appeal shall be considered by the city council. Said appeal body shall hold a hearing on said appeal and shall render its decision thereon within thirty days after filing thereof. Said body may reverse or affirm or modify the decision of the design review board or the decision or interpretation of the planning director and such action shall be final.

Chapter 17.58 USE PERMITS

17.58.050 Appeal. [repealed]

A. An appeal to the city council may be filed by any person aggrieved by a decision of the appropriate authority. Such appeal shall be in writing and shall be filed with the city clerk within ten days after written notice of the decision has been mailed to the applicant. At the time of the filing of the appeal, the appellant shall pay a filing fee to be established by resolution of the city council from time to time hereafter enacted. An appeal shall set forth specifically the points at issue, the reasons for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the appropriate authority.

B. Upon receipt of the notice of appeal, the city council shall set a date for public hearing thereon, giving notice thereof pursuant to Section <u>17.58.030</u>. The city council may reverse or affirm, wholly or partly, or may modify the order, make such order, requirements, decision, or determination as should be made, and such action shall be final.

Chapter 17.60 VARIANCES

17.60.060 Appeal. [repealed]

A. An appeal to the city council may be filed by any person aggrieved by a decision of the planning commission. Such appeal shall be in writing and shall be filed with the city clerk within ten days after written notice of the decision has been mailed to the applicant. At the time of the filing of the appeal, the appellant other than the applicant shall pay a filing fee to be established by resolution of the city council from time to time hereafter enacted. An appeal shall set forth specifically the points at issue, the reasons for the appeal, and wherein the appellant believes there was an error or abuse of discretion by the planning commission.

B. Upon receipt of the notice of appeal, the city council shall set a date for public hearing thereon, giving notice thereof pursuant to Section <u>17.60.040</u>. The city council may reverse or affirm, wholly or partly, or may modify the order, requirement, decision or determination appealed from, and may make such order, requirement, decision or determination as should be made, and such action shall be final.

Chapter 17.70 Appeals

17.70.010 - Planning commission authority Purpose.

17.70.020 - Application Appeal subjects and appeal authority.

17.70.030 – Action by planning commission filing of appeals.

17.70.040 – Appeals Time limits.

17.70.050 - Processing of appeals.

17.70.010 Purpose.

Determinations or actions of the Community Development Director or his/her designee, or planning commission may be appealed by this chapter.

17.70.020 Appeal subjects and appeal authority.

Determinations and actions that may be appealed, and the authority to act upon an appeal, shall be as follows:

- (A) Staff Determinations. The following determinations and actions of the community development director or his/her designee may be appealed to the planning commission and then to the council.
 - (1) Director's Determinations on the meaning or applicability of these regulations that are believed to be in error.
- (B) Decisions of Review Authorities. Generally, decisions of the Director and the Tree Committee may be appealed to the Planning Commission, and decisions of the Planning

Commission may be appealed to the council. When a single project requires two or more permit applications, or where final action on an application is subject to deadlines which cannot reasonably be satisfied if an application is subject to multiple appeals, any appeal of the project shall go to the higher-level appeal authority among those permits. The decision of the City Council shall be final.

17.70.030 Filing of Appeals.

- (A) Who May File an Appeal. An appeal may be filed by:
 - (1) Any person affected by an administrative determination or action by the department; or
 - (2) Anyone who, in person or through an authorized representative, appeared at a public hearing in connection with the decision being appealed, or who otherwise informed the City in writing of the nature of their concerns before the hearing.
- (B) Timing and Form of Appeal. All appeals shall be submitted in writing on a City application and shall specifically state the pertinent facts of the case and the basis for the appeal.
 - (1) Appeals shall be filed in the community development department or, in the case of appeals of Planning Commission actions, in the office of the city clerk, within 10 <u>calendar</u> days following the final date of the determination or action being appealed; provided, that the time for appeal may be shortened to five days by the decision-maker whose decision is subject to appeal where final action on an application is subject to deadlines that cannot reasonably be satisfied if there is a longer appeal period.
 - (2) Appeals shall be accompanied by a written report stating specifically wherein it is claimed there was an error or abuse of discretion by the Commission or wherein its decision is not supported by substantial evidence in the record. The Council shall only hear the appeal if the notice is filed and all required fees are paid within the ten (10) calendar day appeal period. An appellant may submit a written request to withdraw their appeal any time before the scheduled hearing for the appeal.
- (C) Scope of Appeals. An appeal of a decision on a community development permit shall be limited to issues raised at the public hearing, or in writing before the hearing, or information that was not generally known at the time of the decision that is being appealed.

17.70.040 Processing of Appeals.

- (A) Scheduling of Hearing. After an appeal has been received, the matter shall be placed on the next available agenda of the appeal authority and within sixty (60) days.
- (B) Notification of Applicant. Within three (3) business days of receipt of an appeal, staff shall attempt to notify the applicant.

- (C) Joining an Appeal. Only those persons who file an appeal within the time limit established shall be considered appellants. Any person who wishes to join an appeal shall follow the same procedures for an appellant. No person shall be allowed to join an appeal after the expiration of the time limit for appeals.
- (D) Action and Findings. The appeal authority shall conduct a *de novo* public hearing. At the hearing, the appeal authority may consider any issue involving the matter that is the subject of the appeal, in addition to the specific grounds identified in the appeal.
 - (1) The appeal authority may affirm, affirm in part, or reverse the action, decision, or determination that is the subject of the appeal, based upon findings of fact about the case. The findings shall identify the reasons for the action on the appeal and verify the compliance or non-compliance of the subject of the appeal with these regulations.
 - (2) When reviewing a decision on a community development permit, the appeal authority may adopt additional conditions of approval that may address other issues or concerns than the subject of the appeal.
 - (3) Effective Date of Appeal. A decision by any appeal authority other than the City Council is effective on the eleventh day after the decision, if no appeal to the decision has been filed, or before the next regularly scheduled meeting. Because a decision by the City Council is final, unless in certain circumstances when a property is located in the Coastal zone, it is effective as of the date of the decision, unless the Council specifies an alternative date.

CITY COUNCIL CONSIDER RECEIVING AND ADOPTING RESOLUTION NO. 2025-, RECEIVING AN UPDATE AND APPROVING THE SCHEMATIC DESIGN FOR THE MARINA AQUATIC & SPORTS COMPLEX (CIP# QLF 2004).

REQUEST:

It is requested that the City Council consider adopting Resolution No. 2024-:

- 1. Receiving an update; and
- 2. Approving the schematic design of the Marina Aquatic and Sports Center Complex; and
- 3. Finding this action is exempt from CEQA pursuant to Section 15061 (B)(3) of the CEQA guidelines.

BACKGROUND:

On November 19, 2024, the City Council received an updated presentation from COAR Design Group and Isaac Sports Group for the renovation and development of the Marina Aquatic and Sports Center Complex. The City Council approved the following:

- 1. Confirmed the previously approved agreement (Resolution No. 2022-21 for \$1,772,000) with COAR Design Group for the architecture schematic design, final design, construction and bidding document preparation and architecture support services during construction of the Marina Aquatics and Sport Center Complex.
- 2. Authorization to forward with building of the full Marina Aquatics and Sports Center that includes Phase 1, Phase 2 and the connector building at an approved amount of \$41.4 million dollars.
- 3. Funding for the project will come from FORA bond funds, FORA Escrow bond funds, and the former FORA community facilities district fees that are paid by only the Dunes and Sea Haven developments. The former FORA community facilities district fees are still coming in over the next 5 to 7 years and the General Fund will need to temporarily loan approximately \$11 million dollars for this project until these fees are fully collected.
- 4. Direct staff to continue to work with COAR and Issac Sports group on updating the financial operating model.
- 5. Direct staff to bring back to the City Council the final schematic design for approval.

DISCUSSION

COAR Design Group will be making a presentation at the City Council meeting of the proposed final schematic design for the project including Phase 1, Phase 2, and the connector building.

Upon final schematic design approval:

- COAR Design Group will proceed with design development of the aquatic center, sports center, 2-story connector building, and associated site work.
- Staff will explore alternative delivery methods such as construction manager at risk (CMAR). CMAR is a delivery method where the construction manager acts as a consultant during design and construction and commits to delivering the project with a guaranteed maximum price.
- COAR Design Group will continue to coordinate with the Dunes City Park project designers to ensure a cohesive design and coordinated site/utility work.

- At the end of the design development phase cost estimates will be updated and potential value engineering options evaluated, if needed, to keep the project on budget.
- The project will then proceed into construction documents, bidding, and construction.
- Staff will continue working with Isaac Sports Group on the financial operating model.

The estimated construction schedule will be provided in the presentation. Staff anticipates a 12-month construction phase beginning in April 2026. The anticipated grand opening of the Marina Aquatic & Sports Center Complex is April 2027.

ENVIRONMENTAL REVIEW:

This action is not a project subject to the California Environmental Quality Act pursuant to the exception found in section 15061(b)(3) of the CEQA Guidelines.

FISCAL IMPACT:

The projected \$41.4 million project cost will be funded from restricted former FORA fees. The General Fund will need to temporarily loan an estimated \$11 million for this project which will be repaid from collected FORA fees.

CONCLUSION:

This request is submitted for City Council consideration and comment.
