1. CALL TO ORDER

2. ROLL CALL: (Police Dept, Engineering/PW Dept, Community Development & Fire Dept) Chief Hopkins, Chief Doug McCoun, Carlos Vega, Edrie Delos Santos, Cmdr. Richard Cox, PW Director Ismael Hernandez, Admin Michaelle Mowery, Liesbeth and Min Chan from the public present.
3. **PUBLIC COMMENT: Visscher states that she is happy there is a “no left turn” from Imjin to 3rd and wanted to thank us that this is open to the public. Since 2018.**

Min Chan has submitted traffic complaints the last couple of weeks on California Ave. Same work truck, same vehicles at 7am, he thinks people just don't care, noise from trucks increase with speed.

4. ACTION ITEMS: *Action listed for each Agenda item is that which is brought forth for Traffic Committee consideration and possible action. The Traffic Committee may, at its discretion, take action on any items. The public is invited to approach the podium to provide up to four (4) minutes of public comment.*

- a. 4 E's (Enforcement, Education, Empowerment, Engineering)
Action Items: Address traffic safety concerns brought to group by public, Engineering: Road concerns, signs, markings. Enforcement: PD, Code Enforcement. Education: Social media, Laws of the road, Safety, Reminding residents. Empowerment: Give residents opportunity a change to talk, forms to fill out, neighborhood watch program. Hopkins states this is a great framework to follow, Edrie states the 4 E's is what we use in the office and engineering is the easiest for him and we are a city of one engineer and the education portion is the hardest to convey because its complex and that is why we have so many consultant teams. MPE has put out additional stop signs at 9th and California Ave for their work trucks and contractors they work with. MST has been notified of drivers to stop completely at the intersection. Requests for additional speed limit signs, this doesn't limit speeders, signs are not the answer. Additional efforts are enforcement, looking into speed radar signs. Commander Cox states officers have been made aware of this area and have been dedicating their time here, but most of these violators are during daytime hours. Chief Hopkins states we have a running list throughout the city of vehicles the city of vehicles and we try and keep track of this, but

they don't just have one for "traffic." PD can't be there all day/everyday but overtime they are trying.

CSUMB should be notified that if this is a thorough fair they should be told that they would be subject to tickets and law enforcement. Michaelle will notify PD and maintenance. Ismael states this meeting will be 1 hour long in the future, so we will coordinate between meetings via email.

May 6th the speed study will go before council it's an engineering and traffic study that needs to be done every 5 years, we will present data and give to PD to enforce. Vega states only concern would be Speed bumps, and requests to be included, he works closely with code enforcement and prevention.
