7. COUNCIL AND STAFF ANNOUNCEMENTS:

- Councilmember McAdams made comments about Community Human Services 2024 Annual Report. Spoke about recent data that was released relating to homeless students in California. Monterey County being the highest at 16% of unhoused students.
- Mayor Delgado commented on the number of homeless students; and state that he and Mayor Pro Tem Visscher are going to go on a 3-day conference in Tulare County, Central Valley for a Compassionate system training. Announced two cleanups scheduled for June 8th at 10:00 am corner of Del Monte and Lapis Rd. and on June 29th at the abandoned camping areas near the old bridge club on Fort Ord. On June 12th there is an important water meeting at the California Public Utilities Commission in Sacramento. Spoke about the 4th of July Festival at the Marina Airport. Made comments about the 50th Anniversary of Interim Inc.
- Councilmember McCarthy commented on the raising of the Pride Flag over on Sunday and thanked everyone who showed up. Announce he will be attending remotely the League of California Cities meeting. Commented on Access Monterey Peninsula (AMP Media) and their need to fill some vacancies on their board. Person interested can contact me or the executive director of AMP Media.
- Councilmember Biala commented on the recent data on homeless students and is concerned about the numbers. Asked how the schools are helping the unhoused students.
- Mayor Pro Tem Visscher commented on the FORTAG trail and how it connects neighboring cities. Announced on June 18th TAMC will be holding a community meeting at the Marina Equestrian Center from 4:00-6:00pm to discuss the part that will be constructed in Marina, along California Avenue.
- City Manager Long announced that the regularly scheduled council meeting of June 17th has been cancelled and rescheduled to June 24th
 - 8. PUBLIC COMMENT: Any member of the public may comment on any matter within the City Council's jurisdiction that is not on the agenda.  few local companies have sent in emails of interest for this project.

- Paige Viren, Executive Director, Sustainable Hospitality and Tourism Management Program at CSUMB. Spoke on behalf of the students studying for careers in hospitality and tourism. Their future success depends on a strong and resilient tourism economy, which requires consistent and strategic investment in destination marketing. Asked Council to continue to support See Monterey (Monterey County Convention and Visitors Bureau).
