- 4. OTHER ACTION:
 - a. Adopting **Resolution No. 2025-83**, amending sales tax revenue sharing agreement between the City of Marina and Unstoppable Automotive MBMCA LLC to assist in covering high site development and construction costs associated with developing a Mercedes-Benz automobile dealership in Marina.

Public Comments:

• Mike Kennedy feels that Mercedes-Benz of Monterey would be appropriate. The Council should focus more on repairing the streets and streetlights, fixing our medians and painting/striping the streets.

The council members discussed not having more public participation in this meeting due to the short notice; about losing the global branding footprint Mercedes of Marina would have brought that the sign be in perpetuity and consistent with City monument design requirements. They spoke about long-term economic value on branding coming to Marina and asked how the City of

Marina would be included in the marketing and Mercedes making possible donations to the city after 10-20 years of being in business.
