Re: Martin Luther King Jr. Sculpture

At the Tuesday, June 23, 2020 City Council meeting, the Council approved amendments to the FY 2020/21 Budget. At this meeting, there was a discussion regarding providing funding to restore and find a location for the Martin Luther King Jr. bust which has been in storage at the airport. There was support from the Council to restore and display the bust. The Council ultimately decided to see if the community and general public wanted to get involved in raising private funds for this project and did not allocate any General Fund money for the project at this time.

By the next day, Wednesday, June 24, a \$5,000 donation was made to the City to assist in offsetting the costs of displaying the Martin Luther King Jr. bust (attached letter from Marina Citizens for Accountability in Government). Additionally, there was another \$10,000 donation made, and the Marina Foundation has agreed to be a fiscal conduit for the \$10,000 donation and any future donations from the public. On June 25, a social media and web campaign was begun and the following link was established: https://www.themarinafoundation.org/community/dr-martin-luther-king-jr-sculpture-project.html

Monterey Peninsula Engineering has also indicated a willingness to help with heavy equipment needed for this project.

The original artist, Barrington C. McLean has indicated his willingness to polish, refurbish, and repair as needed the Martin Luther King Jr. bust and panels as needed. In addition to the bust, there are four granite panels and one of the panels may need to be replaced.

With the start of \$15,000 in public donations, staff is requesting direction from the Council to add this project to our work program and begin the process to restore the bust and initiate a public process to evaluate potential site locations. We would suggest involving the City's Recreation and Cultural Services Commission to lead the public process in considering appropriate sites. In addition to finding a site, there will be other potential associated amenities (e.g. benches, landscaping, pathways, lighting, security etc.). There will also need to be consideration of having this as a standalone site, or possibly part of a sculpture garden.

Dear City Manager Layne Long,

We are aware that the City Council did not fund the request for the placement of the Dr. Martin Luther King Jr. sculpture at the June 23, 2020 City Council meeting but we also heard that there was a willingness to consider this again if there was a show of community support via raised funds that would offset partially, or in total, the amount deemed necessary to accomplish the placement.

Because we feel strongly that this sculpture is inspirational and the words of Dr. King that are chiseled beautifully into the pedestal will be a show of commitment by our City to the values those words express, we are enclosing check number 151 in the amount of \$5,000 to assist in offsetting the costs of the proposed placement.

There have been past attempts and failures to bring this sculpture out of storage for prominent placement in our community and we believe that we are at a point in our history where we should not fail to do so again. An additional consideration in the historical perspective relative to this sculpture is that the sculptor, Barrington McLean was the first African-American instructor at Cabrillo Community College where he taught from 1969 to 1979. Mr. McLean still lives in Santa Cruz and it would be wonderful if we were able to have him come to any reinstallation ceremony.

On the matter of the placement, we also strongly believe that placement of the sculpture in a public park, specifically Locke Paddon, would be superior to that of City Hall, particularly as the location of City Hall may change in the future, and this would allow many more citizens and visitors, who visit the park and the nearby public library, to enjoy it and contemplate its meaning. This location would also require permission from Regional Parks, I believe, so that should also be considered.

We would ask that in response to this donation, the City and Council give new consideration to this project and that any such project be completed within the next year, or sooner if practical. If the Council does not wish to pursue this project, or cannot do so within the next 12 months, we ask that the \$5,000 be returned.

RECOMMENDATION TO CONSIDER ADOPTING RESOLUTION NO. 2020-, APPROVING AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN THE CITY OF MARINA AND CSG CONSULTANTS, INC. OF FOSTER CITY, CALIFORNIA, TO EXTEND THE CURRENT CONTRACT TO JUNE 30, 2023, AND AUTHORIZE THE CITY MANAGER TO EXECUTE THE AMENDMENT ON BEHALF OF THE CITY SUBJECT TO FINAL REVIEW AND APPROVAL BY THE CITY ATTORNEY

REQUEST:

It is recommended that the City Council:

- 1. Consider adopting Resolution No. 2020-, approving Amendment No. 1 to the agreement between the City of Marina and CSG Consultants, Inc. of Foster City, California, extending the current contract to June 30, 2023, and;
- 2. Authorize the City Manager to execute the amendment on behalf of the City subject to final review and approval by the City Attorney.

BACKGROUND:

On April 4th, 2006, the City Council adopted Resolution No. 2006-84, approving an Agreement between the City of Marina and CSG Consultants (the "Agreement") to provide engineering inspection services to the City's Engineering Division. The original agreement was amended on July 18th, 2006 (Resolution No. 2006-184), March 6th, 2007 (Resolution No. 2007-44), June 3rd, 2008 (Resolution 2008-119), June 19th, 2012 (Resolution 2012-90), October 16th, 2012 (Resolution 2012-156), June 21st, 2016 (Resolution 2016-88), and December 6th, 2016 (Resolution 2016-154). The contract amendments extended the term of service and added staff augmentation for code enforcement, building inspection, building plan check, and solid waste franchise agreement review services.

At the December 6, 2016 regular City Council meeting, City Council also directed staff to issue a Request of Proposals (RFP) for consulting firms providing engineering and building services. Of the seven area firms that received the RFP, CSG was the only firm that responded. Staff contacted the other potential proposers and found that the firms either partnered with CSG as a sub-consultant or did not have the breadth of services or depth of staff to support the contract.

At the regular meeting of August 2, 2017, the City Council adopted Resolution No. 2017-76, approving an agreement between the City of Marina and CSG Consultants for engineering and building permit services.

ANALYSIS:

CSG Consultants, Inc. has been providing engineering and building services since 2006. With continued development and ongoing capital needs, the City will continue to need the services of consultants in both the Engineering and Building disciplines. Those services include but are not limited to: Development review, plan check for code compliance, code enforcement, construction management & inspection services, building inspection, project management, grant application and compliance, and the day to day engineering and building services to assist the Community Development and Public Works Departments.

The City Council approved a Building Inspector and an Associate Engineer position in the FY 19/20 budget to move some of the needed functions in-house. Given the current fiscal downturn, positions are being frozen and if eventually filled will require a period of overlap to transition the specific functions.

If approved, the contract services would continue to support the functions of engineering, building plan check, map check, inspection, and code enforcement. The amended contract term of service would be through June 30, 2023.

FISCAL IMPACT:

The services provided under this contract are funded through budgets within the Capital Improvement Program (CIP), permit fees, and developer agreements. General Fund contributions would be for a portion of Code Enforcement and the engineering and inspection within CIP projects that are budgeted to use General Fund dollars but are one-time expenditures.

There is no retainer under the terms of the contract and compensation is on an hourly reimbursement basis for services rendered. The City has the option to increase or decrease the work performed by CSG Consultants as development and the Capital Improvement Program respond to the fiscal conditions.

CONCLUSION:

This request is submitted for City Council consideration and possible action.

FIRST AMENDMENT TO AGREEMENT WITH CITY OF MARINA AND CSG CONSULTANTS FOR ENGINEERING AND BUILDING CONSULTING SERVICES

THIS FIRST AMENDMENT ("First Amendment") to the Agreement for Engineering and Building Consultant Services to provide engineering and building permit services pertaining to City projects and development and to provide support services for the City on an as-needed basis as determined by the City Engineer is made this 1st day of July 2020, by and between the City of Marina, a California charter city ("CITY") and CSG Consultants, Inc. a California corporation ("CONTRACTOR"). CITY and CONTRACTOR are sometimes referred to herein collectively as the "Parties."

Recitals

- A. On September 11, 2017, CITY and CONTRACTOR entered into the Agreement for services to provide engineering and building permit services pertaining to City projects and development and to provide support services for the City on an as-needed basis as determined by the City Engineer.
- B. The Agreement provides it may only be amended or modified by written agreement of the Parties. Both Parties now desire to amend the Agreement to extend its term to June 30, 2023 and to provide compensation in accordance with **Exhibit B-1** to be furnished by the CITY for work performed on and after July 1, 2020.
- C. The CONTRACTOR has prepared **Exhibit B-1** for the proposed amendment of the Agreement (attached as "**Exhibit B-1**" to this First Amendment incorporated herein by reference).
- D. Only the numbered Articles of the Agreement which are being amended are set forth in this First Amendment.

Terms & Conditions Amended

Now, therefore, the Parties agree to amend the Agreement as follows:

- 1. **"Exhibit B-1"** to the First Amendment is incorporated into the Agreement.
- 2. Article 2 "Terms of Agreement & Commencement of Work" Section (a) and (b) is amended to read in its entirety
- (a) The term of this Agreement began on September 11, 2017, the date of its full execution, and the Agreement as amended shall expire on June 30, 2023 unless further extended by amendment or terminated earlier as provided herein. The date of full execution is defined as the date when all of the following events have occurred:
- (i) This Agreement has been approved by the City's Council or by the board, officer or employee authorized to give such approval; and

- (ii) The office of the City Attorney has indicated in writing its approval of this Agreement as to form; and
- (iii) This Agreement has been signed on behalf of Contractor by the person or persons authorized to bind the Contractor hereto; and.
- (iv) This Agreement has been signed on behalf of the City by the person designated to so sign by the City's Council or by the officer or employee authorized to enter into this Contract and is attested to by the Marina City Clerk.
- (b) "CONTRACTOR commenced work on the Project on September 11, 2017. This agreement may be extended upon written agreement of both parties. CONTRACTOR may be required to prepare a written schedule for the work to be performed, which schedule shall be approved by the CITY and made a part of "Exhibit A."
- 4. Article 3 "Compensation" Section (a) and Section (d) are amended to read in their entirety:
- (a) "CITY liability for compensation to CONTRACTOR under the Agreement as amended shall only be to the extent of the present appropriation to fund this agreement. For services to be provided under this Agreement and the First Amendment CITY shall compensate CONTRACTOR in accordance with the provisions of this Section and at the hourly rates attached hereto as **Exhibit B-1** and described in Recital B."
- (d) "CONTRACTOR shall not receive any compensation for Extra Work without the prior written authorization of CITY. As used herein, "Extra Work" means any work that is determined by CITY to be necessary for the proper completion of the Project but which is not included within the Scope of Work and which the parties did not reasonably anticipate would be necessary at the execution of this Agreement. Compensation for any authorized Extra Work shall be paid in accordance with "Exhibit B-1."

All other terms and conditions of the Agreement shall remain in full force and effect.

This First Amendment may be executed in two (2) counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument. Counterpart may be delivered by facsimile, electronic mail (including pdf. or any electronic signature complying with the U.S.ESIGN Act of 2000, California's Uniform Electronic Transactions Act (Cal. Civil Code 1633.1 et seq.) or other applicable law) or other transmission method and any counterpart so delivered shall be deemed to have been validly delivered and be valid and effective for all purposes.
