## MOBILE FOOD VENDOR STANDARDS AND AGREEMENT

**Mobile Food Vendor as defined in § 10.46.020 of the Marina Municipal Code:** “Mobile food vendor” means a person who sells, displays, solicits, or offers for sale, exchange, gift, or otherwise conveys food or beverages from any vending vehicle on a public street or private property.

| A. | <b>Compliance with applicable laws.</b> Mobile food vendors shall operate at all times in compliance with all applicable local, state, and federal laws and standards including, but not limited to the County of Monterey Health Department, the <a href="#">California Health and Safety Code</a> , the <a href="#">California Vehicle Code</a> , and the <a href="#">Chapter 10.46</a> Mobile Food Vending and Sidewalk Vending of the Marina Municipal Code.                                                   |          |
| B. | <b>Limitations.</b> Mobile food vendors shall not display, sell, or exchange any item other than food and/or beverages within city limits. Not display, sell, or exchange any beverage containing alcohol.                                                                                                                                                                                                                                                                                                         |          |
| C. | <b>Garbage, Recycling and Food Waste.</b> Mobile food vendors shall provide garbage, recycling, and food waste receptacles for immediate use by customers. Pick up, remove, and dispose of all garbage and/or materials and food waste dispensed from the vending vehicle and any residue deposited on the street from the operation thereof, and otherwise maintain in a clean and debris-free condition the entire area within a twenty-five-foot radius of the location where mobile food vending is occurring. |          |
| D. | <b>To-go containers.</b> Mobile food vendors shall comply with <a href="#">Chapter 8.50</a> , prohibiting the use of polystyrene foam containers, and requiring that to-go containers are made from biodegradable, compostable or recyclable products. Further, vendors shall comply with <a href="#">Chapter 8.60</a> , which prohibits the use of single-use plastic carryout bags. All carryout shall be done using recycled paper bags or reusable carryout bags.                                              |          |
| E. | <b>Vehicle storage.</b> Store all vehicles and foodstuffs at an approved commissary or commercial location approved by the county of Monterey health department. No mobile food vending vehicle shall be stored at any residential property within the City of Marina.                                                                                                                                                                                                                                             |          |
| F. | <b>Public right-of-way.</b> Operate only from public streets with adequate curb, gutter, and sidewalk improvements and shall only conduct business from a licensed vehicle, wagon, trailer, or truck on a public street while parked in a legal parking space.                                                                                                                                                                                                                                                     |          |
| G. | <b>Three Hour Parking Limit.</b> Mobile food vendors shall not conduct business or operate on the same block for any longer than allowed by parking restrictions on the block, but in <u>no event for longer than three hours</u> , and shall not within a period of two hours again operate such vehicle within the limits of such block.                                                                                                                                                                         |          |
| H. | <b>Hours of Operation.</b> Mobile food vendors shall only operate in commercial, industrial, airport, multi-family residential or open space zones between the hours of 7:00 a.m. and 11:00 p.m. Further, vendors shall not conduct business or operate within one block of any public or private school grounds on days that school is open between the hours of 8:00 a.m. and 5:00 p.m.                                                                                                                          |          |
| I. | <b>Violations.</b> Any violation of the City of Marina’s <a href="#">Mobile Food Vending ordinance</a> may result in administrative fines of up to \$1,000 ( <a href="#">GC 51039</a> ).                                                                                                                                                                                                                                                                                                                           |          |
| J. | <b>Permit Renewal.</b> Mobile food vendor permits expire on June 30th each year and it is the vendor’s responsibility to renew prior to expiration.                                                                                                                                                                                                                                                                                                                                                                |          |
| K. | <b>No Smoking/Vaping Sign.</b> Vehicle shall include clear signage indicating that smoking and vaping are prohibited within 25’ of the mobile food vending facility per MMC 8.09.030.                                                                                                                                                                                                                                                                                                                              |          |
